

OCTO Auto Service Plus Contest Rules – "Leave us a review on Google and get a chance to win a getaway valued at \$1000!"

1. ELIGIBILITY

The OCTO Auto Service Plus contest - **"Leave us a review on Google and get a chance to win a getaway valued at \$1000!"** is open to legal residents of Quebec, Ontario, New Brunswick and Nova Scotia.

Employees, officers and directors of Vast-Auto Distribution Ltd. (OCTO Auto Service Plus) (the **"Sponsor"**) and its affiliates, including its parents, subsidiaries, related companies, representatives, agents, contest agency, advertising and promotional agency and each of their immediate family members (defined as parents, spouses, siblings, and children, regardless of where they live) and those with whom they reside (whether or not they are immediate family members) are not eligible.

2. CONTEST PERIOD

The Contest begins on April 7, 2025, at 9:00 a.m. (ET) and ends December 12, 2025, at 11:59 p.m. (ET) (the **"Contest Period"**). The Sponsor's computer server is the sole determinant of the date and time of receipt of an entry and is the official time-measuring device for this Contest.

3. PARTICIPATION

No purchase necessary. Participants across Quebec, Ontario, New Brunswick and Nova Scotia are invited to register on the OCTO Auto Service Plus website (link to our website). Registration via the contest page of the website (link to our site), a valid phone number and a valid email address are required for registration. Ordinary internet and usage charges may be imposed on you by your internet or telephone provider.

To enter the contest, participants must:

- a) Scan the QR code on the invoice pocket or tent card collected in the repair shop. It leads to the contest page "Leave us your review on Google and get a chance to win a getaway worth \$1000!" (<https://octoautoserviceplus.com/contest/win-a-getaway/>) and then select the name of the repair shop where the service was performed. Complete the registration form and provide their last name, first name, telephone number, and email address (the " **Personal Information** "). Finally, leave a Google review on the repair shop to validate your participation in the contest.
- b) Agree to and agree to abide by the contest rules, available online.
- c) Be 18 years of age or older

Participants can only register once. Each participant can only win one prize (one (1) getaway from a local business of your choice valued at \$1000!) and this prize is non-transferable. Anyone who accumulates more than the limit of one entry will be disqualified and all entries received from that person during the Contest Period will be void.

Entries that are late, lost, stolen, ineligible, contain incorrect information, are incomplete, have been submitted in a non-compliant manner, or do not comply with the terms and conditions of these Rules will be void. All entries become the property of the Sponsor upon receipt and will not be returned. The Sponsor is not responsible for lost, late, illegible, incomplete or misdirected entries. 4. PRIZES

There is only one (1) prize to be won, i.e. one (1) "getaway from a local business of your choice valued at \$1000!" for all participating OCTO Auto Service Plus mechanical shops. The odds of winning one of these prizes depend on the number of entries received during the Contest Period.

Prizes must be accepted as awarded and may not be transferred, sold, given, assigned or exchanged. Prizes may differ from those depicted in the contest advertisement or promotional materials. The Sponsor reserves the right to substitute any prize with a prize of equal or greater value if it is unavailable for any reason. All expenses, taxes and costs related to the acceptance and use of a prize that are not mentioned in these rules are the responsibility of the winners.

5. SELECTION OF WINNERS

Prizes will be awarded by a random draw from among all eligible entries received.

The draw will take place on December 15, 2025 (ET).

The selected entrant will be contacted by email and/or telephone within ten business days of the draw date. To be declared a winner, the selected entrant must:

- a) Scan the QR code on the invoice pouch collected in the repair shop. It leads to the contest page "Leave us your review on Google and get a chance to win a getaway worth \$1000!" (<https://octoautoserviceplus.com/contest/win-a-getaway/>) and then select the name of the repair shop where the service was performed. Complete the registration form and provide their last name, first name, telephone number, and email address (the "Personal Information"). Finally, leave a Google review on the repair shop.
- b) Sign and return a declaration, release, release and publicity consent form that confirms, among other things, that he/she has complied with the Contest Rules and releases the Sponsor, its employees, representatives, agents, advertising and promotional agencies, affiliates, directors, officers, shareholders, partners, contractors, agents, distributors, representatives, successors and assigns (collectively, the "Representatives") from any and all Liability for the Prizes won (the "Declaration") within 10 days of the date on which he/she is notified that he/she has won the Prize.
