



OCTO Auto Service Plus Contest Rules – “OCTO Auto Service Plus Gives You a Helping Hand!”

1. ELIGIBILITY

The OCTO Auto Service Plus Contest – “OCTO Auto Service Plus Gives You a Helping Hand!” is open to legal residents of Quebec, Ontario, New Brunswick, and Nova Scotia.

Employees, officers, and directors of Vast-Auto Distribution Ltd. (OCTO Auto Service Plus) (the “Sponsor”), as well as its affiliated companies, including parent companies, subsidiaries, related entities, representatives, agents, the agency responsible for administering the contest, advertising and promotion agencies, and each of their immediate family members (defined as parents, spouses, siblings, and children, regardless of where they reside) and those with whom they reside (whether related or not), are not eligible to participate.

2. CONTEST PERIOD

The contest begins on March 31st, 2026, at 9:00 a.m. (ET) and ends on March 31st, 2027, at 11:59 p.m. (ET) (the “Contest Period”). The Sponsor’s computer server is the sole determinant of the date and time of receipt of an entry and is the official timekeeping device for this contest.

3. HOW TO ENTER

No purchase is required. Participants from Quebec, Ontario, New Brunswick, and Nova Scotia are invited to register on the OCTO Auto Service Plus website (<https://octoautoserviceplus.com/contest/win-a-gift-card/>) by completing the entry form available on the contest page and providing a valid phone number and email address; standard internet and usage fees may be charged by their internet service provider or mobile carrier.

To enter the contest, participants must:

- a) Like our Facebook page and click on the link in the contest post on the OCTO Auto Service Plus Facebook page, which directs you to the “OCTO Auto Service Plus Gives You a Helping Hand!” contest page (<https://octoautoserviceplus.com/contest/win-a-gift-card/>), complete the entry form by providing your first name, last name, phone number, and email address to subscribe to our newsletter (the “Personal Information”).
- b) Agree to the contest rules, available online, and accept to be bound by them.
- c) Be 18 years of age or older.

Participants may enter only once. Each month, one (1) winner will be randomly selected from among all eligible participants and will receive a \$100 gift card redeemable at a café, gas station, or grocery store. Each participant may win only one prize for the entire duration of the contest, and the prize is non-transferable. Once registered, participants are automatically eligible for subsequent monthly draws, provided they remain subscribed to the newsletter and have liked the Facebook page; no additional registration is required. Any individual who exceeds the limit of one (1) entry will be disqualified, and all entries submitted by that person during the contest period will be void.

Late, lost, stolen, ineligible, misdirected, incomplete, or inaccurate entries, as well as entries that do not comply with these rules, will be void. All entries become the property of the Sponsor upon receipt and will not be returned. The Sponsor is not responsible for lost, late, illegible, incomplete, or misdirected entries. The Sponsor is not responsible for any warranties related to the products included in the gift baskets.

4. PRIZE

There are twelve (12) prizes to be won, consisting of twelve (12) “\$100 gift cards redeemable at a grocery store, gas station, or coffee shop,” available to all participants. The odds of winning one of these prizes depend on the total number of entries received during the Contest Period.

Prizes must be accepted as awarded and cannot be transferred, sold, gifted, assigned, or exchanged. Prizes may differ from those shown in contest advertising or promotional materials. The Sponsor reserves the right to substitute any prize with one of equal or greater value in the event that a prize is unavailable for any reason. All expenses, taxes, and costs associated with the acceptance and use of a prize that are not expressly stated in these rules are the responsibility of the winners.

5. WINNER SELECTION

Prizes will be awarded through a random draw from all eligible entries received.

The draw will take place on the last business day of each month.

The selected participant will be contacted by email and/or by phone within ten (10) business days following the draw date. To be declared a winner, the selected participant must:

No other use or disclosure of personal information will be made by the Sponsor unless participants have provided consent through the registration form.
